A tufted carpet consisting of a pile of 80% wool and 20% nylon and a polyamide (PA) monofilament, precoated with SBR latex and PP film on a backing of polypropylene (textile).

Total thickness: 9.6 mm Carpet weight: 2.0 kg/m² Max. organic content: 44% Colour: Dark grey / black

For testing on the standard calcium silicate board, the glue Ege 90 RH was used.
