The test samples were glued to a standard calcium silicate board with "ege 90 RH".

# Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as floor coverings on any non-combustible substrate.

Approved for all colour variations.
